

# BSG Valentine - Privacy Notice

## Introduction and background

The purpose of this policy is to outline how BSG Valentine has established measures to protect your privacy and information rights.

## Your rights

We recognise that you have rights as a 'data subject', and that we have an obligation to uphold these.

This privacy notice aims to outline how we maintain these rights. In particular, it outlines:

- How we collect and process your information
- Why we do this
- How you can exercise your rights in respect of your personal data
- Who to contact in the event you are unhappy with our collection, storage and processing of your personal data.

### Your information rights

Right	Explanation
Right to be informed	This encompasses the obligation for us to be transparent in how we collect and use your personal data.
Right of access	You have the right to access your personal data and supplementary information.
Right to rectification	If the information we hold on you is inaccurate or incomplete, you can request we correct this.
Right to erasure	You can request we delete or remove personal data where there is no compelling reason for us to continue processing.
Right to restrict processing	You have the right to request we cease processing your data, if: <ul style="list-style-type: none"> <li>• You consider it inaccurate or incomplete;</li> <li>• Where you object to processing and we are considering whether we still have a legitimate interest to process it.</li> </ul>

	<ul style="list-style-type: none"> <li>• Where we don't need the data for the original reason we collected it.</li> </ul>
Right to data portability	<ul style="list-style-type: none"> <li>• Where you have consented to our processing your data, or where the processing is necessary for us to deliver a contract, you can request a copy of that data be provided to a third party in electronic form.</li> </ul>
Right to object	<p>You have the right to object to our processing under certain circumstances. For example, you can object to:</p> <ul style="list-style-type: none"> <li>• direct marketing (including profiling); and</li> <li>• processing for purposes of scientific/historical research and statistics</li> </ul>

Data regarding clients personal identity and proof of address.	To comply with Money Laundering Regulations	We process this data internally to fulfill regulatory requirements and data is held in line with our data retention policy.
Current and former employees and candidates for employment	To fulfil general HR and finance administration including payroll and benefits and for any	We process this data internally and data is held in line with our data retention policy.

## Transfer of data

We may share/process personal information with carefully selected third parties based outside the EEA (e.g.. WhatsApp, Microsoft) for the the purposes of communicating with clients, or to provide contracted services. We ensure that third parties which we share your personal data with are GDPR compliant.

## Retention of data

BSG Valentine has a documented data retention policy which governs how long we hold your personal data for. This is in line with our legal and regulatory requirement and as protection from future litigations.

## Securing your information

We have a number of technological and physical security measures to protect your personal data, and to keep your information secure at all times. This is in line with industry standards and best practice.

A cookie is a small text file written to your hard drive that contains information about you.
